प्रताप कुडाळकर हे नेहमीप्रमाणे शेतात देवपूजेसाठी लागणारी फुले काढण्यासाठी गेले होते. दुर्दैवाने या वाटेवर तुटलेली जीवंत वीज वाहिनी लगतच्या कुंभनावर लटकत पडली होती. श्री. कुडाळकर यांना या तुटून पडलेल्या वीज वाहिनीची कल्पना नव्हती. चलात असताना या वीज वाहिनीला त्यांचा स्पर्श झाल्याने विजेचा धक्का बसून त्यांचा जागीच मृत्यू झाला.
