A Summary of Proceedings of 23rd Annual General Meeting

The 23rd Annual General Meeting (AGM) of the Members of Intrasoft Technologies Limited (the Company) was convened at 3.00 PM (IST) on Wednesday, 12th September, 2018 at Sunville, Orchid Room, 9, Dr. Annie Besant Road, Worli, Mumbai- 400018 and concluded at 4.30 PM.

Mr. Arvind Kajaria Chaired the Meeting. The requisite quorum as per the provisions of the Companies Act, 2013 was *present*.

The Chairman briefed the members about the working and business performance of the Company.

The Chairman then covered the Items of the Ordinary Business and Special Businesses and explained the objective and implications of all the Resolutions.
