Notes:

- The above results which are published in accordance with Regulation 53 of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 have been reviewed by the Audit Committee and approved by the Board of Directors at their respective meetings held on February 12, 2026. The financial results are in accordance with the Indian Accounting Standards (Ind-AS) as prescribed under Section 133 of the Companies Act, 2013, read with the relevant Rules thereunder. These results have been subjected to a limited review by the Statutory Auditors of the Company who have issued unmodified audit conclusion thereon.
- As per the requirement of IND AS 108 as notified under Companies (Indian Accounting Standards) Rules 2015 as specified under Section 133 of the Companies Act, no disclosure is required for Segment reporting as the Company is operating in single business segment of Internet based delivery of services.
- Deferred tax include reversal of MAT Credit Entitlement for FY2010-11 unutilised/lapsed till current reporting period, amounting Rs. 83.99 lacs. (Previous year includes Rs. 115.72 lacs for FY2009-10)
- The Government of India has consolidated 29 Labour Codes ("New Labour Code"), effective from 21st November 2025, with the related rules yet to be notified. The Codes, inter alia, introduce a uniform definition of wages which has impact on gratuity and leave liability. The Company has assessed the impact of these changes, which is not material and hence will be accounted for at the year end 31.03.2026, if any. The Company will continue to monitor developments and assess any further impact on employee benefit liabilities.
- Previous period figures have been re-grouped/re-classified wherever necessary, to conform to current period's classification.
